RISK OF INJURY: "As a participant in the programs, or as a parent or legal guardian of a participant under 18 years of age, I recognize and acknowledge that there are certain risks of physical injury, and I agree to assume the full risk of injuries, including death, damages, or loss which I may sustain as a result of participating in the basketball tournament" WAIVER OF INJURY CLAIMS: "I agree to waive and relinquish any and all claims I may have arising out of, connected with, or in any way associated with the activities of the programs." RELEASE FROM LIABILITY: "I do hereby fully release and discharge ATH and its officers, agents, and volunteers from any and all claims from injuries, including death, damage or loss which I or my minor child/ward may have or which may occur on account of participation in the basketball tournament. INDEMNIFY AND DEFENSE: "I further agree to indemnify, hold harmless and defend ATH and its officers, agents, and volunteers from any and all claims from injuries, including death, damages, and losses sustained by me or my minor child/ward and arising out of, connected with, or in any way associated with the activities of the basketball tournament." In the event of any emergency, I authorize the public entity to secure from any licensed hospital, physician, and/or medical personnel any treatment deemed reasonable and necessary for my minor child's immediate care and agree that I will be responsible for payment of any and all medical services rendered. I have read and fully understand and agree to the above stated conditions of participation.
